

## Program Overview



*Summer Lab: Israel* is a journey integrating touring throughout the beautiful and multi-faceted country of Israel with immersive, hands-on lab science on the Givat Ram campus of the Hebrew University of Jerusalem.

Week One-Arrive in Israel and meet your fellow participants from the U.S. and Israel as well as your staff. Explore the vibrant, tech-savvy city of Tel Aviv before heading to the Negev desert. You'll spend the first shabbat on a kibbutz in the Arava desert and enjoy some fun in the sun in Eilat.

Week Two-Begin the lab science program at Hebrew U and explore Jerusalem's 3,000 years of history. Experience Shabbat at the Western Wall (Kotel) and take time to recharge your own batteries.

Week Three-Spend more time in the lab and exploring Jerusalem and places farther afield. Set off for the Dead Sea and Masada before spending Shabbat in the mystical city of Zefat. Return to Hebrew U for your final presentations and farewells to your new friends from Israel and the U.S.

### **Belmonte Science Labs of Hebrew University**

Keshet has partnered with Hebrew University's youth division to implement the Lab Science portion of the program. The Belmonte Science Laboratories Center was founded in 1990, with the goal of creating a state-of-the-art science education center for high school pupils and their teachers to pique their interest in natural sciences. At Belmonte students actively learn science with a vast range of experimental and hands-on activities. The primary fields of interest in Belmonte are chemistry, biology, and physics.

For many years, Belmonte has been a focal point for educational innovation and challenge while providing high school pupils with access to academic infrastructures and current research.



The Belmonte Labs are located on the Edmond J. Safra (Givat Ram, Jerusalem) campus of Hebrew University. The complex also includes the Beit Bretter guest house where *Summer Lab* fellows with stay while in Jerusalem. Beit Bretter offers clean, modest rooms, a private dining room, classrooms, and informal meeting spaces.

The core program promotes scientific thinking, curiosity, research skills, and critical thinking. It covers selected contemporary topics in science, providing exposure to academia. The center's staff includes Hebrew University researchers, and the instructors are mostly university graduate students.



### Part 1: A Taste of Science: Introduction to Scientific Exploration

The first three introductory laboratory sessions will introduce all participants to key scientific principles in chemistry, physics, and biology. Students will be divided into three laboratory groups, allowing them to explore each discipline.

Part 2: After completing the introductory sessions, students will choose a focus area: Chemistry, Physics, or Biology. They will then participate in five advanced laboratory sessions in their chosen field, followed by a research project.



Certificate of Participation: Upon completion of the core program, each *Summer Lab* fellow will receive a certificate, noting the number of academic hours and signed by the Director of the Belmonte Labs.

### RootOne Vouchers and Payment Information



There are a limited number of \$3000 RootOne vouchers available. They will be granted on a “First Come, First Served” basis to those who meet eligibility requirements and return the completed registration form and pay the deposit. RootOne Vouchers are available for Jewish teens who are entering 10th, 11th, or 12th grade or graduating high school in the Summer of 2026.

- The RootOne voucher will be paid directly to Keshet on your behalf and will be deducted from your final payment.
- Teens must complete the RootOne pre-trip early requirements (*nekudot*) to receive their voucher
- Voucher recipients are required to participate in post-trip engagement and evaluation.
- Teens are only eligible to receive a voucher once.

*Vouchers are contingent upon requirements being met. Non-fulfillment of these obligations and/or removal from the program due to a Code of Conduct violation will result in a forfeit of a voucher.*

- Upon Registration, participant's will be sent an email with instructions to complete a Personal Statement and provide 2 Letters of Recommendation. Upon submission, the participant will be invited for a personal interview (by GoogleMeet).
- Keshet Educational Journeys is committed to creating the best possible experience for all participants. Through our interview and application process, Keshet aims to ensure every participant is set up for success in our programs. Should we find that this program isn't the right match for an applicant at this time, we'll notify you and fully refund the deposit.

  - It is recommended to use Google Chrome when registering.
  - After opening the link, for security reasons, if left open and unsubmitted, the link will automatically expire within 48 hours and the information on it will not be saved.
  - To avoid expiration, participants should aim to finish the application process as soon as possible once the link is opened. The application should take less than 20 minutes to complete.
  - If the link expires, go back to the original link above and repeat
- Copy of Passport – send a copy of the front page. This information is required for hotels and medical insurance in Israel.
- Participant Code of Conduct form - signed by both the participant and a parent/guardian. Due by May 28, 2026
- Release & Waiver of Liability-signed by a parent/guardian due by May 28, 2026

## Travel Details

### Passport

- Passports are required for travel to Israel.
- A copy of the participant's passport is also required.
- Passports must be valid at least through February 19, 2027, six months beyond the program return date.
- U.S. and Canadian passport holders do not need a visa to enter Israel.
- For other nationalities, check with the nearest Israeli consulate.

### ETA (Electronic Travel Authorization)

- As of January 1, 2025 all visitors to Israel (non-Israeli citizens) are required to apply for an ETA (Electronic Travel Authorization). The cost of the ETA is NIS 25.
- A response to the ETA application will be received within 72 hours. Make sure to print out the ETA confirmation and keep it with your passport.
- The ETA will be valid for a two-year period, for multiple trips of 90 days or less within that period. If any single visit will be for more than 90 days, a request for an extension of that stay must be submitted.

Israeli citizens must enter and leave Israel on their Israeli passport and do NOT need to fill out an ETA. If you are an Israeli citizen or if one or more of your parents is an Israeli citizen or if you lived in Israel previously, please contact the Israeli consulate to determine your legal status in Israel and to procure an Israeli passport if needed.



### **Luggage**

Most airlines allow one checked bag up to 50 lbs. and one carry-on item. You will be traveling extensively within Israel, so we recommend one large duffel bag with wheels. When you pack your luggage remember that less and lighter is better as you will be frequently unpacking and repacking.

Please do not to pack any liquids in your carry-on luggage. All electrical appliances need to be adaptable to 220 voltage and have adapter plugs.

### **Arrival in Israel:**

Please schedule arrival for **Monday afternoon July 27**. The trip rendezvous point will be in the Arrivals Hall of Ben Gurion airport (TLV). A Keshet staff member will be there from 1:00-5:00pm to greet arriving participants.

### **Departure from Israel:**

The program officially ends after dinner on **Tuesday night August 18<sup>th</sup>**. There will be a group transfer to Ben Gurion airport for departing flights. A Keshet staff person will be at the airport until 1:00 am to supervise check-in. We recommend booking one of the many flights to North America which depart between 11:30pm and 1:00am.

## Insurance Information

### Personal Property Insurance

*Keshet* does not cover loss or damage to baggage or personal belongings. Please check your family's homeowner's insurance to see if you are covered for such situations. In view of statutory or contractual limitations which may apply to personal injury or property damage losses, the purchase of accident and baggage insurance is strongly recommended.

### Medical Insurance and Medical Information

*Summer Lab: Israel* tuition includes medical coverage during the trip. You are covered during the program by *Har-El* Insurance Company in Israel. This insurance covers medical services anywhere in the country. The insurance covers up to \$300 for medication and emergency dental work, full hospital coverage (according to the terms of the policy up to \$100,000) and doctor's costs. Please note that drunkenness and suicide attempts are not covered by the policy. The insurance does not cover preexisting conditions for either medical care or medication. The insurance does not cover Sexually Transmitted Diseases or Pregnancy. Psychological or psychiatric treatment or medicine is not covered by the regular insurance program, however we will refer individual program participants or staff for counseling in case of need.

You do not need any special shots before you go to Israel, but we strongly recommend that you consult your physician to make sure that your tetanus shot is up to date.

If you are taking any prescription medication, please bring it with you. Do not plan on purchasing it in Israel. It should be in the original package with the prescription label intact. The generic (chemical) name of the medication should also be displayed.

Teens are responsible for carrying and self-administering their own medication. Our staff is not allowed to hold or administer prescribed medication and cannot be responsible for ensuring that prescribed medication is taken. Should your teen's medication require refrigeration, please so note on your registration form. If you have any concerns regarding medications, please contact Keshet.

Covid-19 guidelines: Keshet operates its programs under the rubric established by the Israeli Health Ministry concerning entrance to the country, pods, social distancing, sanitation of facilities and isolation requirements. The regulations are updated on a regular basis. Currently there are no restrictions or requirements in place regarding Covid-19.

### Travel Insurance

Keshet strongly urges you to purchase trip cancellation/interruption insurance and supplemental medical coverage (which covers pre-existing conditions). Please note that we cannot accept responsibility for any losses or expenses which you may incur as a result of failure to secure adequate insurance coverage.

### ***During Summer Lab: Israel***

#### **Shabbat & Kashrut Observance**

Shabbat is a time to pause, reflect, and strengthen community bonds. On Shabbat, teens are expected to dress in clothing that reflects the sanctity of the day. Friday night services may be held in a local synagogue, the Kotel (Western Wall) or in-house and begin with a joyful community gathering with photos and snacks. Saturday programming includes services at local synagogues or led by staff and teens, reflective activities, discussions, and rest. Phones are not permitted on Shabbat in public spaces to maintain the spirit of the day and respect those who may be Shabbat observant. There will be no group vehicular transportation on Shabbat, and all activities will be within walking distance or on-site, fostering a restful and communal atmosphere.

There are no group activities that violate traditional shabbat observance. On Shabbat there will be both traditional egalitarian and creative prayer options. Daily prayer is not part of the program. We will assist individuals who are interested in participating in daily prayers but cannot guarantee a minyan.

#### **Program Meals**

- Breakfast, lunch, and dinner are included in the program fee.
- All food provided on the program is Kosher.
- Program meals take on a variety of forms and may include buffets, packed lunches, restaurants, vouchers and “cash meals” when each participant is given money in shekels to purchase their own food in a designated area with a variety of choices.
- Keshet also provides snacks throughout the program but teens may wish to purchase additional snacks on their own.
- Teens may be introduced to new foods that they aren’t accustomed to. We encourage teens to keep an open mind and try the unique delicacies offered in Israel.
- Participants with special dietary restrictions (vegetarian, vegan, lactose-intolerant, gluten-free, most food allergies) can be accommodated with advance notification (please note accordingly when registering). Keshet cannot accommodate those with severe allergies that are airborne and/or require no cross-contamination. Please be in touch with us in advance with your needs to discuss whether we can provide appropriate meals.



## Spending Money

The United States Dollar (USD) to *shekel* conversion rate is roughly 3.30 shekels to one USD. Before the summer, please check online for the updated conversion rate.

All meals are provided by Keshet but extra spending money is needed for snacks, gifts, etc. You can obtain Israeli shekels from most Israeli ATM machines with your US or Canadian issued ATM or credit card. Many Israeli Banks are part of the PLUS Network; some are also on CIRRUS. Please contact your bank prior to your departure to be sure that you are able to use your card overseas and for clarification of fees and withdrawal limits if any. Please do not bring more than \$100 in cash. Do **not** bring traveler's checks.

You may also use VISA, MasterCard & American Express cards for nearly all transactions in Israel. Please contact your credit card company prior to your departure to let them know that you will be travelling in Israel and for clarification of fees if any. ApplePay and GooglePay are widely accepted.

## Time Difference



Israel is seven hours ahead of the U.S. Eastern time zone. Please note the time difference when contacting participants or the *Keshet* office.

## Contact with Home



### Email

The Keshet office will notify families by email when the participants arrive safely in Israel. Periodically, families will receive e-mail updates from the program group leader.

## Cell Phone



There are restrictions as to when phones may be used during the program. In general, cellphones are not allowed during group activities and programs. Program staff will give specific instructions at the beginning of the program. There will be free time each day when participants may use their phones.

While in Israel, you may wish to have the convenience of a SIM card for your phone or a basic cell phone. While you are free to order from any company that you wish, Keshet has made arrangements with **019 Mobile** to provide discounted rates for unlimited calls and text in Israel, unlimited calls to the US and Canada, a virtual US number, a data package and the option to rent a mobile phone during your stay in Israel.

- You can place your order through the unique website that has been created for you. After you're done ordering your phone plan, you'll receive an invoice sent to your email with an invoice number.  
When you land in Israel, you have to go to the **019 Mobile** shop at the exit of the airport and you'll receive your package there. **019 Mobile** is open 24 hours a day, 6 days a week (closed on Shabbat), so even if you're landing at night, we'll be there for you.  
To qualify for these specials, please be sure to order your package up to **3 days before your** using your link.

The **country code** for Israel is **972**. The **area code** for Jerusalem is 2, for Tel Aviv 3, for the south 8 and for the Galilee 4. Example: A call from the US to Jerusalem would be dialed as follows: 00972-2-phone # and a call from Jerusalem to the US would be dialed as follows: 019-1-city code-phone # (without the 0)

### **Security**

Your safety is our top priority. Keshet takes proactive measures to ensure everyone's safety during the program. The Keshet staff is in constant contact with Israeli security forces (military, police and civilian) and all itineraries are given prior clearance. There will be a group leader and two counselors with the group throughout the entire trip. There will also be a full-time guard/medic with the group when off the Hebrew University Givat Ram campus.

Keshet coordinates its security policy for youth groups with the National Situation Room, which in turn is linked to the Israeli Police and the Israel Defense Forces (IDF). The Situation Room monitors all potential hazards that may impact upon our programs, including weather conditions, road conditions and security situations. Keshet Senior Staff and tour guides receive real-time SMS (text messages) to their cell phones.

Our security protocols are standard for youth programs in Israel.

- Keshet youth programs are assigned an armed guard who accompanies the program on bus trips, hikes, and any touring off the Givat Ram campus. The guard also serves as a medic or First Aid provider, unless one of the other staff is also a trained medic. Keshet hires its guards from a licensed security company which screens and trains them.
- Program staff are briefed in advance on emergency procedures and communication of their situation to the senior Keshet staff.
- If the security situation deems it necessary, Keshet will alter itineraries, including changing overnight accommodations, in keeping with relevant security considerations.

### **Program Dismissal**

Participants and parents/guardians must sign the enclosed "Code of Conduct". In short, usage of, or any involvement with alcohol, drugs or narcotics will be grounds for dismissal from the program at any time; vandalism or destruction of public or private property will be dealt with in the same manner. In addition, if a participant leaves the hostel/campsite at night (sneaking out) they will be sent home immediately. **NO SECOND CHANCES WILL BE GIVEN FOR ANY OF THESE ACTIONS.** Body piercing and tattooing of any kind done in Israel is also forbidden for health reasons. Should the staff deem it necessary, an individual may also be sent home due to unacceptable behavior.

Participants who choose to break one of the rules of the program will be sent home at the sole discretion of Keshet. No refunds will be made in case of dismissal from the program. It is additionally understood that should a participant be dismissed from a program for behavioral misconduct as laid out in the code

of conduct, or due to injury or illness caused by reckless behavior, not only will the participant's RootOne Voucher be forfeited, **but the family will be held responsible for remaining costs of the trip.** This of course does not apply if a participant becomes ill or injured through no fault of their own or must return home due to reasonable extenuating circumstances.

## FAQ's

**How much free time will I have?** While the itineraries are quite intensive, we do set aside time for relaxation, shopping, and "hanging out". Because we take your safety and security so seriously, there will understandably be some limits on personal exploration time. Teens are not allowed to leave the group. Free time varies daily depending upon the itinerary. Generally speaking there will be some free time every evening before curfew in addition to other times during the program.

**Should I bring my laptop for lab work?** You do not need to bring a laptop with you. Belmonte has computers available for your use. Should you decide to bring a laptop or tablet, you will be responsible for its safekeeping. Keshet cannot be responsible for any lost, stolen, or damaged items.

**What happens if I have dietary restrictions?** We are able to accommodate most requests (vegetarian, vegan, lactose-free, gluten free) but cannot guarantee no cross contamination. If you have other food allergies, make sure to note them on your registration form. Check the "Program Meals" section of the handbook for more details.

**Where do we stay?** While in Jerusalem, we will be staying at the Beit Bretter Guest House. While touring through Israel, we will stay at 3 star hotels, superior youth hostels, or kibbutz guest houses. There will be 2-4 participants per room with private bathrooms and a/c. One night we will camp out in a Bedouin tent. Sleeping bags will be provided and there are bathroom and shower facilities.

**Is it really that hot in Israel?** Yes! Most days will be in the high 80s, 90s and possibly reach 100+ when in Eilat and the Dead Sea Region. The coastal region can be quite humid while the rest of the country is dry. The sun is strong from early in the morning until early evening. For this reason, hats and water bottles are a MUST when outdoors during the day.

**How many participants will be on the program?** The minimum size will be 15. Maximum is 45. There will be a ratio of 1:8 Israeli teens to American teens.

**I haven't studied biology, chemistry or physics yet in school. Is that a problem?** Absolutely not! All that is required is an interest in science and curiosity to learn more.

**I have family/friends in Israel. Can I visit them? Can they visit me?** That's great and we absolutely want you to meet up with your family or friends who live in Israel. While you cannot leave the program, they can visit you during your free time if coordinated in advance with your program staff.

**Health insurance is included in the program fee while in Israel. Should I get travel insurance?** Keshet recommends that you purchase insurance to offer you the greatest protection should any unforeseen circumstances arise. Check the Travel Insurance section in the handbook for details.

- Clothing should be geared towards the informality of the program.
- Please remember that Summer is extremely hot in Israel and you should bring clothes that are lightweight and breathable.
- Keep in mind that you will have to pack, unpack and travel with all your luggage during the program.
- Laundry service is included twice during the program.

## CODE OF CONDUCT

**Keshet aims to create a safe, supportive, and secure environment for all participants and staff. Here are the conditions under which we accept your participation. Read them carefully before you sign the contract below.**

**To ensure that everyone has an amazing experience, the following activities are strictly prohibited and will result in removal from the program:**

- Drinking and/or possession of alcoholic beverages
- Use and/or possession of any illegal drug, including marijuana, and/or supplying drugs or drug paraphernalia to any person. Participants may not distribute prescription medication to any other participant.
- Smoking, consuming, or distributing tobacco products, including “Nargilot” (water pipes)
- Handling/possession of firearms, knives, or any item that could be used or construed as a weapon.
- No hazing, bullying, or any other form of violent behavior, whether consensual or not, will be tolerated under any circumstances.
- No intimidation, threats of violence, sexual harassment or other forms of inappropriate controlling behaviors, verbal, physical, or written.
- No repeated profanity or disrespectful comments, including but not limited to those regarding race, gender disability, sexual orientation, or religion.
- No physical sexual behavior or contact, with or without consensual agreement. Your enrollment designation determines whether you are housed with males or females. Our policy prohibits participants of one gender entering the sleeping quarters of the opposite gender. You will be required to stay in the housing accommodation that is consistent with your designation. Our policy prohibits sexual contact of any kind.
- No possession of pornographic materials in written or digital format.
- No body alterations including piercing and tattooing **while in Israel**.
- No vandalism, graffiti, disturbing the peace or other inappropriate behavior (any damages will be paid for by the person(s) responsible.
- No hitchhiking
- No driving any vehicle, including a tractor
- You are not to remove yourself from any part of the program or leaving the location of the program without consent of your group leader. “Sneaking out at night”, whether from a hostel or campsite.
- You may not invite guests to join you for any part of the program without advance permission of your group leader.

**The following rules are expected to be followed at ALL times:**

- Full cooperation with your group leaders is mandatory and you are expected to treat them respectfully at all times
- Curfews are to be observed, as is promptness at all group activities.
- Property and privacy of others must be respected under all circumstances
- Proper dress code as per instructions of group leaders. Appropriate footwear as defined by the staff. No tank tops, tube tops, or other sleeveless clothing may be worn (for sun protection and cultural respect); hats must be worn at all times while outdoors during daylight hours to prevent dehydration.
